# **AMCHP Conference Highlights Issues**



The **Association of Maternal and Child Health Programs (AMCHP)** featured a plenary session and a workshop on state strategies for improving preconception health. For the plenary - "Preconception Care: Identifying New Opportunities to Improve Women's and Children's Health," the speakers were Tonya Lewis Lee and Dr. Maxine Hayes.

Tonya Lewis Lee, wife of film director Spike Lee, is an advocate for education in infant mortality, which includes a role as official spokesperson for the "A Healthy Baby Begins with You" campaign launched by the US DHHS Office of Minority Health. Ms. Lee said that the U.S. ranks 29th in the world for infant mortality. "It's despicable, shameful and horrible," she said. "Most of the babies dying are African American, Hispanic and Native American. I feel not just for our women, but for our nation."

Dr. Maxine Hayes, Health Officer for Washington State, gave a powerful set of messages in her speech. The quotes that follow give a flavor of what she shared. "Women are the engine that keeps this nation moving forward, so it is in everyone's best interest to keep women healthy at all stages of life. Women are also the decision-makers on all health matters in families. For example, women decide who goes to the doctor for what and when; what food is purchased and how it is prepared; if immunizations are received; and if appointments for preventive care are kept...An investment in women's health is an upstream prevention policy action. In the past, the only time our nation has been willing to invest in a woman's health is after she gets pregnant. That is far too late...

We must maximize every opportunity to optimize a woman's health prior to conception, planned or not. Doing so means promoting women's health over the lifespan and across the entire spectrum of public health programs... Timing is everything, and the time has come for MCH to be leaders for a woman's health agenda. I see the health of women as core to the health of entire communities... Remember, you cannot achieve what you can't envision. Let's all envision a new era for MCH, the heart of which are healthy women, healthy families, healthy communities, a healthy nation and a healthy world!"

## **Putting Preconception Health and Health Care into State Action**

Leaders working on preconception health issues in California and Delaware presented in a workshop at the AMCHP conference.

This session highlighted three distinct approaches that have been used by states to advance preconception health. First, a number of states have created new partnerships and coalitions to advance work in this area. Second, some states are integrating preconception health services into existing programs such as family planning. Third, states have taken a more comprehensive approach that involves

Title V, private, and other resources to expand programs and access to care. Each has increased access to services for women of childbearing age

- Maryjane Puffer (Director of Clinical and Community Health Programs for California Family Health Council, Inc.) spoke about a special initiative in Title X Family Planning.
- Kiko Malin (Preconception Health Coordinator in the Maternal, Child & Adolescent Health Division of the
  Center for Family Health in the California Department of Public Health) described the creation and
  activities of the California Council on Preconception Care. The Council is a public-private partnership
  involving an array of state leaders.
- Charlan Kroelinger (Scientific Director in the Center for Family Health Research and Epidemiology and State MCH Epidemiologist for the Delaware Division of Public Health) presented a case study of efforts from the legislature to community level services in Delaware.
- Kay Johnson (Senior Advisor to the CDC Preconception Health and Health Care Initiative) served as moderator for the session and gave an update on current activities across the country.
